#### COMMITMENT

The Leadership Institute requires a strong commitment as each participant is required to attend every session of the program, from the overnight retreat to the monthly class sessions in order to graduate from the program. The overnight retreat is August 30-31, 2018 and the monthly sessions will be held Fridays from 8 a.m. – 5 p.m. on October 12, 2018; November 9, 2018; December 7, 2018; January 11, 2019; February 8, 2019; and March 8, 2019.

#### COST

Program tuition is \$2,300 for Chamber members and \$2,800 for non-Chamber members. The tuition covers costs for the monthly sessions, retreat, all program materials, meals and the graduation ceremony. A \$100 deposit is required upon acceptance into the program. Tuition must be paid in full by July 6, 2018 and is non-refundable after August 17, 2018.

### **SCHOLARSHIPS**

The Chamber offers partial scholarships based on financial need. They are funded through the "Van Rensselaer Fund – Rensselaer County Regional Chamber of Commerce" through The Community Foundation. These scholarships will be awarded by The Leadership Institute Selection Committee. The amount of each scholarship is determined each year by the availability of funding. Recipients of the scholarships will be notified along with their acceptance to The Leadership Institute. Requests for financial assistance will not affect consideration for participation in the program.
