## \$1.3 Million Gaming Hubs Expected to Spur Business

**¬** mpire State Development (ESD) is funding digital gaming hubs at three high-tech Juniversities in New York State, including Rensselaer Polytechnic Institute. The gaming hubs will receive \$150,000 each, per year, for three years with the goal of encouraging students and businesses, particularly entrepreneurs and start ups, to develop new products and spur economic growth.

Rensselaer Polytechnic Institute, New York University and Rochester Institute of Technology were selected through a Request for Proposals process. The funding objectives are to foster innovation and collaborative activities among

industry, higher education, non-profit organizations, students and individuals to create new gaming technologies and companies.

The hubs are expected to provide resources and mentoring to encourage students and entrepreneurs to enter the growing gaming industry while assisting them with technologies and hosted events that draw together regional gaming communities.

"There is tremendous talent and creativity in games, here in the Capital Region and throughout the state," said Ben Chang, associate professor and director of Rensselaer's Games and Simulation Arts and Sciences Program. "University researchers are discovering new ways of using games in education and health care, nonprofits are teaching game design to kids and



building creative communities, and game developers of all kinds are constantly reinventing the medium. We're honored to be selected as one of three Digital Gaming Hubs, and excited to be working with our partners in the local community and across the state to take game development in New York to the next level."

## State Promises Universal Broadband by 2018

The New NY Broadband Program is the state's effort to ensure universal access to affordable, high-speed broadband services in urban, suburban and rural communities. Working to close the digital divide that has left many areas unserved or underserved, state officials contend that access to broadband internet increases opportunities for businesses, communities and individuals of all ages. The program seeks to spur economic growth and job creation through universal access to online resources such as education, high-tech research, job training, workforce development, new business markets and more. The \$500 million program offers financial incentives to the private sector to expand high-speed broadband access in targeted areas. Applications will be chosen through a "reverseauction" process, with funding awarded to bidders seeking the lowest state investment. Auctions will be held within each Regional Economic Development Council region to ensure statewide allocations of funding. For applications, visit nysbroadband.ny.gov.

- Provide access to broadband at speeds of at least 100 Mbps; 25 Mbps in the most remote areas.
- Require publicprivate partnerships with a 50% match in private sector investment.

he United Group of Companies, Inc. has been chosen by the Hudson Valley Community College's Board of Trustees to build and operate privately owned student housing near the college's Troy campus. Construction at the 41-acre site at the corner of Morrison and Vandenburgh avenues (the former Hy Rosenblum Administration Center) is expected to be complete and ready to receive HVCC students by June 1, 2017.

The property, purchased by the college in the 1980s, once housed administrative offices, a day care center and a paramedic program. The building has been vacant for more than five years. Following an October 2015 request for proposals, it was sold to the United Group for \$268,000. Plans call for the development of a four-story residence with 72 fully furnished apartments totaling 268 beds. Each apartment

will include a living room, dining area and full kitchen. The building's three wings will form an interior patio for recreational use and on-site amenities include 24-hour security, a fitness center, great room, laundry, bike storage, cable/internet and on-site management offices. More than 200 parking spaces adjacent to the building will be available to residents. United will work with LeChase Construction Services based in Rochester and architecture+ located in Troy.

"Hundreds of (HVCC) students relocate to this area each year. Ever greater numbers are asking for housing options," said Drew Matonak, HVCC president. "As we expand our recruitment activities around New York State and abroad to boost international student enrollment, we're looking forward to having a new opportunity to offer housing near campus." The growth, spurred by an expansion of the carrier's contract with United Airlines, comes less than a year after CommutAir opened a new \$4.2 million Regional Economic Development Council grant-funded maintenance facility at the airport in Colonie. Construction of the 17,000-square-foot maintenance hangar was funded by a \$3.8 million state grant through the Regional Council process, with the balance funded through the airport authority. The hangar doubled the size of the company's facility and allows for rigorous maintenance checks on its fleet. CommutAir also leases space in the former Eclipse Aviation hangar for employee training.

CommuAir represents United Airlines (under the name United Express), operating throughout the northeast with more than 100 daily flights. The company offers six daily flights from Albany to Newark and Washington-Dulles but expects to add flights this spring, as well as maintenance-related jobs during 2016. Visit albanyairport.com.





