# Honoring our Manufacturing Past

The Burden Iron Works Museum in South Troy presents a compelling story for today's entrepreneurs, manufacturers, public officials and economic developers. It's the story about the significance—yesterday, today and tomorrow—of deliberate regional technologybased development to advance human societies.

"It is a window into the past and a model for the future," said Michael P. Barrett, executive director of the Hudson Mohawk Industrial Gateway, which operates the museum and preserves the region's historic industrial legacy. "There was a deliberate, coordinated attempt to make cutting-edge technological innovation the focus for regional economic prosperity. This mindset created an environment for innovations that helped to make the region one of the wealthiest in 19th century America."

The transformation of the region at the confluence of the Hudson and the Mohawk Rivers from rural agrarian to urban-industrial resulted in worldwide advances, including the modern horseshoe, the hook-headed railroad spike, cooking and heating stoves, the modern fire hydrant, more than one million detachable collars and cuffs produced *per day* and the lion's share of bells cast in the New World.

During the industrial revolution, visionaries from across the region deliberately constructed a superlative transportation infrastructure, including the Erie Canal, the promotion of steamboats on the Hudson River, the first American railroad line designed for a steam locomotive and construction of numerous bridges. This vision also comprehended a regional educational infrastructure, including Rensselaer Polytechnic Institute and Troy Female Seminary (Emma Willard School), and an investment banking infrastructure comprised of two dozen banks in Troy alone.

Through education for all ages, tours, lectures, research and preservation of the Burden Iron Works building, the Gateway connects the history of manufacturing with its future. *Visit hudsonmohawkgateway.org.*



This year, 300 high school students will attend a keynote presentation, tour on-campus laboratories and watch demonstrations of manufacturing innovations. 


