BUILDING A TRANSPORTATION NETWORK

CDTA Makes Rapid Progress with Grant Monies

Successful awards for federal and state grants totaling more than \$34 million have placed the Capital District Transportation Authority (CDTA) in the driver's seat, as the organization continues to build a premier public transportation network in the Capital District.

A \$26.9 million U.S. Department of Transportation grant, announced in April, guarantees the launch of CDTA's second Bus Rapid Transit (BRT) route, which will operate between Troy-Cohoes-Waterford and downtown Albany. The grant allows construction of the "River Corridor BRT" this year, with a goal of starting service in late 2020, according to CDTA's CEO Carm Basile (photo right). "The grant is the major component of the financing needed to build the BRT line," said Basile.



Further funding for the River Corridor BRT was secured this spring when CDTA won \$8 million in grants from New York State. More than half of the state grants will go towards its operating expenses, such as bus fuel and drivers. The 16-mile, round-trip River Corridor BRT is expected to run 20 buses and make 31 stops. CDTA's first BRT line (known as BusPlus, photo below) was launched in 2011 and operates along Route 5 between Schenectady and Albany. It is CDTA's busiest line.



Approximately \$3.6 million of the state grants will fund bus infrastructure near the Harriman State Office Building Campus and the University at Albany. Improvements to sidewalks, lighting and bus stops will lay the groundwork for a third BRT line that CDTA has planned along Washington and Western avenues. The proposed Washington/Western Corridor BusPlus route will connect downtown Albany, Crossgates Mall, University at Albany, SUNY Poly, the Harriman office campus and the College of Saint Rose. "We will begin making investments in the infrastructure long before that project is ready to roll," Basile said. BRT lines make fewer stops along passenger routes, making them a faster option for commuters and other riders. VISIT cdta.org

THE PORT OF ALBANY-RENSSELAER

Port Gets a "Big-Lift" from Heavy Equipment Success



When General Electric shipped a record 944,000-pound generator from its Schenectady factory through the Port of Albany in May, it represented a major milestone for the port and its goal of being the primary destination for heavy-lift cargo in the Northeast. "This is the beginning of the future that we've all been working toward," said Port CEO Richard Hendrick. The 900-megawatt generator, headed for installation in Thailand, was the single heaviest piece of equipment moved through the port in the past quarter of a century.

The port's success is the result of proactive planning and the investment of more than \$24 million in

funding. The port replaced an 840-foot section of dock in 2018 and constructed a 45,000-square-foot warehouse designed to store cargo weighing in excess of one million pounds. In addition, private investments made by Jeff Dagen, owner of Dagen Trucking in Schodack, have been key to the port's heavy-cargo development. Dagen spent close to \$3 million over the past two years to purchase a gantry crane with the capacity to lift two million pounds and two self-propelled, 18-axle trailers capable of moving one million pounds each. Dagen has a 10-year tenant lease with the port, occupying the new heavy-lift warehouse.

Overall, the Port of Albany-Rensselaer has been making strategic maritime terminal improvements, including a new wharf design and a dock system capable of accommodating the next generation of heavy lift cargo. The dock also ensures reliable bulk product transfer and is capable of meeting the anticipated increase in containerized cargo resulting from the Panama Canal expansion. Flexibility in the berth configuration allows for bulk cargo, container movements, heavy cargo movement and a variety of other uses. VISIT portofalbany.us

Rifenburg Companies



Rifenburg Construction, Inc. is working with the Olympic Regional Development

Authority (ORDA) to transform the Olympic Sports Complex at Mount Van Hoevenberg, Lake Placid, into a world-class destination for athletes and trainers. Rifenburg's \$25.6 million design/build contract will help reinvent the facility and position it to attract Olympic-level competitions, including the 2021 International Bobsleigh and Skeleton Federation (IBSF) World Championships.



"Rifenburg Construction's reputation for large-scale projects is something we are very proud of," said Pat Wellington, project manager. "With Creighton Manning Engineering as our design partner, we're excited to be redeveloping the renowned Olympic Mount Van Hoevenberg bobsled mountain. By creating an International Nordic Trail, a Biathlon Trail System and more, the site will be ready for new generations of topnotch athletes for years to come."

Rifenburg will excavate an estimated 120,000 cubic yards of earth and blast 40,000 cubic yards of rock to clear 23 acres and construct four kilometers of European-style ski trails. Excavation and site preparation will support construction of a new Nordic stadium, Biathlon shooting range, culverts and pedestrian and trail bridges. Rifenburg will also construct a 6.5 million gallon water reservoir for a new snowmaking operation at the Olympic sports complex, including the installation of pipes, pumps, compressors and a pump house.

In support of the construction of a new base lodge, Rifenburg will provide clearing and site preparation, utility relocation, landscape and hardscape. Upgrades will be made to the water, wastewater, power, communications and data infrastructure at the complex, including installation of buried conduits to support transmission of televised sports events from the complex.

Completion of the Mount Van Hoevenberg Transformative Project is scheduled for October 2020. VISIT rifenburg.com ALBANY INTERNATIONAL AIRPORT

\$22 Million in Improvements Coming to Airport

The Albany International Airport will undergo \$22 million in development and improvements, including construction of a new 1,000-car parking garage and modernization of its terminal and passenger amenities. The airport projects, together with the construction of a new Northway exit (article below), are designed to service and attract increasing numbers of air travelers and boost the international reputation of the Capital District as a destination for business and tourism.

The Albany County Airport Authority is initiating and completing several important projects during 2019, each of which will help to sustain and improve the airport. The new multi-level parking garage will expand airport parking capacity by 20% and will include a heated pedestrian bridge to the airport terminal for greater vehicle and pedestrian safety. To the south of the airport terminal, underground utilities are being relocated as well as the position of Jetway Drive. The change will allow travelers to exit the parking garage and access Albany Shaker Road and the new Northway Exit 4 interchange without having to drive in front of the airport terminal. The garage project will include installation of new LED electronic signage, car counting devices and interactive access control devices that utilize advanced GPS technology to locate available parking spaces via wayfinding messages to motorists. Garage construction should be finished by March of 2020.



The airport terminal will see major renovations over the next year with new lighting, a remodeled food court, new escalators, renovated waiting areas and restrooms and enhanced passenger amenities, such as improved internet connectivity. Energy efficient lighting is being installed along the airport's main taxiways. A solar panel system will be installed in the long-term parking area to reduce energy costs and provide outdoor cover for vehicles. In addition, several passenger jet bridges are being replaced.

IMPROVING AIRPORT ACCESS

New Exit Ahead of Schedule

I-87's new Exit 3, the
Northway-Albany Airport
Connector, is on target to
open in late 2019, a year
ahead of its original date.
The exit will provide more
direct access to Albany
International Airport and
alleviate traffic along
the Northway, both



northbound and southbound. The new exit is a key aspect of the airport's \$104.6 million modernization, which is expected to further strengthen the economy of the region.

The \$22.1 million in State funding for the airport is part of a \$54.6 million project to modernize the facility, and is provided through the \$200 million Upstate Airport Economic Development and Revitalization Competition. Other funding for the modernization project is provided by the Albany County Airport Authority and the federal government. The \$50 million airport connector project is funded through the state's \$100 billion Infrastructure Renewal Plan. VISIT dot.ny.gov

O'Donnell will remain CEO as the authority conducts a national search for his replacement and will see the transition through to ensure continuity in leadership. He began his career at the airport in 1996 as director of project development and managed a \$200 million airport expansion that included a \$75 million terminal and five-story parking garage. He also served as chief operating officer prior to 2003.

RIDING THE AMTRAK RAILS

Garage Improvements to Enhance Rail Experience



Improvements at the Albany-Rensselaer Rail Station should be completed this fall, giving train passengers an enhanced experience when they travel the rails. As part of the last stage of an ongoing project, construction at the facility's parking garage resumed in August. The project includes replacing the parking membrane that covers the top deck and protects the garage from the elements, routine maintenance to the physical structure and the addition of parking spaces.

During this phase of construction, customers are not able to drop off passengers at the station's main entrance but can access parking on the east end of the top deck. Customers are encouraged to use the lower levels of the parking garage and surface lots, accessed off East Street in Rensselaer. As a courtesy,

the first hour of parking in the facility is free-of-charge. The Herrick Street Bridge is restricted to east-bound traffic for the duration of the construction.

The garage consists of two parking decks. A third level serves as a public plaza and opens to East Street. The plaza also contains a number of short-term (one-hour limit) parking spaces. A total of 492 and 20 disabled spaces are available on the ground and second levels of the garage. When completed, the project will increase parking on the top deck of the garage to accommodate growing numbers of customers using the station for business and personal travel.
