

#### ASK A BOARD MEMBER: Virtual Training & Education



Kathleen Pingelski is the owner of MicroKnowledge, Inc. and president of its affiliated professional development training company, ProKnowledge, LLC. She manages client accounts and new business development for both companies. With 26 years of experience creating

and delivering programs to end-users and professional trainers, Kathleen collaborates with clients to create effective, efficient training plans and regularly presents to customers, associations and community organizations about the use of technology in the workplace.

# Q » How have your companies adjusted to the pandemic and changing models of business?

A » We changed our business models for both MicroKnowledge and ProKnowledge in a weekend, from 99% in-person training to 100% remote delivery. MicroKnowledge also has had the opportunity to utilize our skill sets to train and support COVID-19 contact tracers and contact investigators in New York and Colorado on the CommCare application, which is used for contact tracing in both states. It has been a great business opportunity and allows us to do meaningful work during the pandemic. In house, MicroKnowledge and ProKnowledge have been able to maintain our team cultures via MS Teams. Many days, it is like we are all sitting right next to each other, even though we are miles apart. We have also hosted virtual happy hours, holiday activities and informal virtual lunches in the "breakroom." Maintaining our team culture is key to our success and growth.

# Q » What makes the Chamber's Quick Learn series so attractive for businesses?

A » Quick Learn sessions are designed to focus on a specific topic, targeting a user's knowledge gap. Rather then overload the learner with a "fire hose" of information, we focus on a topic or feature that is particularly relevant for the learner. Many adult learners can retain smaller chunks of information that build upon one another. So we may need to cover eight hours of content, but by breaking it down into three to four short sessions it works more effectively for the learner. It also fits their busy schedules better to dedicate two to three hours in a day, rather than an entire workday.



**INTiDYN (Integrated Tissue Dynamics)** is a biomedical research firm founded in 2008 by internationally renowned neuroscientists. The company's purpose is to propel basic and clinical research discoveries into the development of effective and safe therapeutics, especially for

chronic pain. INTiDYN uses its pioneering ITD-CMA platform to detect diseaserelated chemical, structural and genetic changes in biopsies of complex tissues, especially human skin. This provides academic, pharmaceutical and biotechnology clients worldwide with expeditious customized research, actionable data and comprehensive interpretative expertise. Based on 50 years of collective biomedical research experience, documented in more than 100 peer-reviewed publications, the company's ability to produce greatly enhanced project outcomes has identified an essential unfulfilled niche market. Further, INTiDYN's small size, collaborative spirit and deep commitment to thinking outside of the box enables the company to be a

nimble research partner, pursuing discoveries wherever the paths may lead. INTiDYN's ideas have created therapeutics that are entering initial clinical tests. One is for treating fibromyalgia, based on their finding of a rational biological source of pain in the skin. Another is for neurofibromatosis, rooted in their discovery of the source for the disfiguring skin tumors of this rare and debilitating genetic disease. Other discoveries are contributing to potential therapeutics for complex regional pain syndrome, diabetic neuropathy



and irritable bowel syndrome. "The skin, with its complex nerve and blood supply, is the site of hundreds of chronic, debilitating diseases that notoriously respond poorly to existing therapeutics," said Dr. Frank Rice, co-founder. "The good news is that the skin, as the body's largest and particularly complex organ, provides a cost-effective and accessible window into what is happening within the body, including the nervous, cardiovascular, immune and endocrine systems. Analyzing complex skin tissue gives us a unique perspective in which to view disease and to discover new effective treatments."
