## Historic State-Wide Cashless Toll System Unveiled



The New York State Thruway Authority is modernizing its 570-mile transportation system by converting to an entirely cashless tolling system that went live in November and will be completed in 2021. The cashless tolls are expected to reduce congestion, improve traffic flow, lower pollution emissions and allow for non-stop travel on New York's toll roads, bridges and tunnels. The work is taking place at 52 Thruway interchanges and barriers across New York, making it an historic milestone for transportation and technology in the state.

**Chamber members Rifenburg Construction New York and A. Servidone, Inc. are two partners in Cashless Tolling Constructors, LLC, a tri-venture company that was awarded the design-build contract. The third partner is Economy Paving Co., Inc. of Cortland, New York. The \$355 million project, which began on September 1, 2019, is proceeding ahead of schedule.**

Motorists are now driving unimpeded under American-made steel gantries with state-of-the-art sensors and cameras that read E-ZPass tags and take license plate images so that vehicles no longer have to stop to pay tolls. Traffic also passes over computerized sensors embedded in concrete slabs in the pavement under the gantries.

Cashless Tolling Constructors installed the gantries at locations across the state, making safety improvements to slip ramps and tandem lot access points to allow motorists to travel more freely along the system. Pre-cast buildings installed near the gantries house computer components and the "brains" of the system.

The switchover to cashless tolling took place simultaneously system wide on November 14, 2020

### NO CASH ACCEPTED

## Get Ready for Non-Stop Highway Travel

If you are wondering how New York's cashless toll system works, here's a quick look:

For motorists with an E-ZPass, tolls are collected using the same process already in place. If you don't have E-ZPass, you can sign-up online or purchase passes at retail locations. [VISIT the-zpassny.com/en/onthego/locations.shtml](https://www.thruway.com/en/onthego/locations.shtml)

Motorists without E-ZPass using the New York State Thruway can pay their toll bill online or wait for a bill in the mail. Billing is sent to the name and address on the car's registration. Toll charges are up to 30 percent more for motorists without E-ZPass, plus surcharges. [VISIT e-zpassny.com](https://www.thruway.com/en/onthego/locations.shtml)

at 1 a.m. By mid-December, deconstruction of six major toll plazas and road reconfiguration was completed and crews were preparing for a winter shutdown. In the Capital area, toll plazas at Exit 25 (Schenectady – I-890), Exit 24 (Albany – I-87) and the Canaan Toll Barrier (Berkshire Spur) were among the first to be completed and traffic is flowing freely. When work commences for the 2021 construction season, the remaining toll plazas state wide will be demolished and road configuration finished.

The total project spans the Thruway from Exit 16 at Harriman in Orange County to Exit 61 at the Pennsylvania state line, approximately 450 miles of roadway that serves more than 158 million vehicles per year.

Logistically, the large project was broken down into distinct geographic divisions, with project managers reporting to a master project manager. The pandemic outbreak challenged safety managers tasked with keeping healthy the 300-400 craft laborers, managers and other personnel spread across the state. "It's been a great effort to keep workers safe, including ongoing sanitizing of surfaces, tools and facilities, social distancing and other protocol," said Mark Servidone, president of A. Servidone and managing partner of Cashless Tolling Constructors. "This is happening at multiple stations geographically distant from one another."

At the remaining toll plazas, drivers will continue to travel through existing toll lanes at 20 mph speeds (without stopping). Drivers are being urged to slow down and use caution around the toll plazas, which are active construction zones. The entire project is expected to be finished by mid-summer of 2021. Motorists can download a new Thruway Authority mobile app, available for free on iPhone and Android devices. The app provides hands-free direct access to real-time traffic and construction alerts, navigation assistance and detailed Thruway services information. Features include:

- E-ZPass and "Tolls by Mail" information.
