### A CONVERSATION WITH: Board Member Paul Kelly



## Member News

St. Peter's Health Partners (SPHP) joined Capital District Transportation Authority's (CDTA) Universal Access Program, giving all employees at SPHP unlimited ridership within CDTA's service network. SPHP has more than 11,000 employees at more than 185 locations. Employees can use any of CDTA's transit services by swiping a Navigator card. The Navigator app is downloaded from the Apple or Google Play stores. The app provides trip planning, so employees can use the CDTA route network to get to other parts of the Capital Region as well. **GlobalFoundries (GF)** announced its U.S.-based employees may receive tax-free financial assistance from the company to pay down student loan debt The new benefit program is part of a multimillion dollar investment by GF to strengthen the semiconductor workforce by helping with the cost of higher education and training. Starting this year, the program allows employees to receive a lifetime cap of \$28,500 toward payment of student debt for eligible loans connected with any degree type or credit-based certificate program offered by American universities and colleges. Capital Roots opened a 2,000-square-foot incubator kitchen designed to give local food entrepreneurs a place to get started before spinning off into the business community. Part of the Urban Grow Center's nearly \$9 million expansion, the incubator kitchen includes four cooking areas (baking, food trucks/catering and two large volume production areas); a food prep area; rentable cold and dry storage space; a dedicated loading bay and 24-hour access. 

## **Mayor Says Businesses are Backbone of Economy**

The Chamber recently talked with incoming City of Troy Mayor Carmella Mantello. A longtime Troy City Council member, she is the first woman to hold the mayorship in Troy, the seat of Rensselaer County and an influential hub of the business community.

 $\mathbf{Q}$ : As Mayor-elect of the City of Troy, what can businesses expect from your incoming administration?

A: Our focus is on creating an environment where businesses of all sizes from start-ups to multinational corporations can thrive. We're committed to making Troy safer, cleaner and more affordable to encourage businesses to start-up, relocate and grow here. Public safety is the most important responsibility of government and we will work to make Troy the safest city in the state.

Moreover, we're dedicated to improving Troy's infrastructure to deliver cleaner water, build better roads and more open and inviting public spaces that spur creativity and attract private sector investment.

Collaborating with local stakeholders like the Chamber, we'll work to streamline city bureaucratic processes and identify opportunities for partnership. Small businesses are the backbone of our community and we will actively engage with them to cultivate a city where success thrives and all of the neighborhoods of Troy prosper.

igQ: What role should government play in workforce development and in addressing the shortage of skilled employees to fill crucial jobs in all sectors?

A: In the post-COVID world, the challenge of recruiting and retaining a workforce has intensified, but our city stands uniquely prepared to address this challenge. Troy boasts a remarkable advantage with three prestigious higher education institutions — Hudson Valley Community College, Russell Sage College, and Rensselaer Polytechnic Institute — within our city limits. This distinctive collection of educational resources sets us apart in a city of our size, providing an extraordinary asset.

My administration is committed to collaborating with these institutions, the business community, and Troy city schools to leverage this strength for our residents' benefit. Together, we'll establish programs engaging grade school students, particularly in underserved areas, exposing them to various career paths from an early age. This won't be a top down effort, this will be bottom up reaching directly into grade schools and neighborhoods to reach the young people, especially our disadvantaged youth, and educate them on the opportunities that are available to them.

Furthermore, by cultivating partnerships with these institutions, we aim to launch initiatives offering practical, skill-focused training that aligns with local businesses' needs. Through internships, apprenticeships, and job readiness programs, our goal is to equip residents, especially those in marginalized communities, with soughtafter skills for prospective employers. This alliance seeks to bridge the education-industry gap, ensuring a steady stream of skilled workers for businesses seeking to hire within Troy.
